Key Points: House Bill 1398 as introduced could:

- ✓ Change 28-years of NH policy to make net metering purely a utility monopoly function and foreclose the ability of CPAs and Competitive Electric Power Suppliers (CEPS) to serve net metered customers.
- Socialize and shift costs from utility default net metering programs onto the backs of CPA and CEPS customers.

Policy Brief: House Bill 1398 was introduced at the start of session in January 2024 and would require the socialization of all costs associated with net metering to all distribution customers through a non-by-passable Stranded Cost Recovery Charge without any accounting for benefits or attempt to pair costs and benefits. HB 1398 would heavily tilt the overall competitive playing field to favor utility default service and could destroy the competitive electricity market in New Hampshire.

HB 1398 would result in:

- 1. Expansion of the utility monopoly over net metering and foreclose the ability of CPAs and CEPS to compete to serve net metered customers.
- 2. Socializing and shifting costs from utility default customers to CEPS and CPA customers.
- **3.** Undo everything that CPCNH has worked tirelessly to do over the past 2+ years to enable use to serve net metered customers and unlock innovation through CPA and competitive service.


